# **Road Rejuvenation/Asphalt Program Start Date**

#### Phase 2

Dear Owner and Resident:

On May 9<sup>th</sup>, Infrastructure Pavement Technologies (IPT) will begin the rejuvenation process between 7 and 8 am for Phase 2 on **the roads designated in the attachment**. This start date is weather permitting and, if it should rain, process begins the day following. This project will have a major impact on preserving our most costly infrastructure, our roads, and will aesthetically improve our community. BUT, WE NEED YOUR HELP!

- Do not drive in areas that are coned.
- Keep all pets off treated areas for twenty-four (24) hours.
- Please limit UPS/FEDEX deliveries during the time your street is being worked on.
- PLEASE DO NOT WALK on the treated areas, as IPT, Atlantic States nor the Board is responsible for the tracking of the rejuvenation process onto any portion of your property.
- Advise children not to play or walk in the treated areas.
- TURN YOUR IRRIGATION SYSTEM OFF the night before and the day of your STREET BEING TREATED. CONTACT YOUR LANDSCAPER AND INFORM THEM NOT TO COME ON THE DAY YOUR ROADS ARE BEING WORKED ON.
- Make arrangements to park your vehicle as directed by the attached document. Please ensure that you read the attachment.
- The postal service and newspaper deliveries will be notified NOT to deliver mail/papers on the day that your street is being treated.

The schedule and parking instructions for the roads to be treated is attached for your review. Infrastructure Team members will visit your homes during the week of May 2<sup>nd</sup> to review the instructions and answer any questions. We all understand that for one/two days, this will be a nuisance but well worth everyone's efforts. Please cooperate with our teams as I know you

**Parking instructions**

## Monday, May 9th

All of: Waterton Circle, Oak Hill Lane, Victory Point Circle, Victory Point Lane and the cul-de-sac at the end of Victory Point Drive. In addition, completion of Waterford Drive up to Crescent Drive. The road from Crescent Drive turning left on Waterford Drive will be closed on Monday and Tuesday, May 9<sup>th</sup> and 10th. All residents who live on Waterford Drive, Oak Forest, Point West, etc. will have to use the back gate for these two days to enter and exit the community.

Parking Instructions: Residents on Waterton Circle can park on Waterford Dr. or Pool Parking lot. Residents on Oak Hill Lane should park at Pool parking lot. Residents on the small section of Waterford Dr. can park further down on Waterford. Residents on Victory Point Lane and Victory Point Circle can park on Victory Point Drive. Please position cars by nightfall on Sunday, May 8th. Autos back to your home on the evening of May 10<sup>th</sup>.

#### Wednesday, May 11th

One-half of Victory Point Drive. As you are coming into the community from Crescent Drive, the right hand lane closest to the driving range will be closed.

Parking Instructions: The only option for parking for the residents in Victory Point is the Pool/Golf Course parking lot. Please position cars by nightfall on Tuesday, May 10th<sup>th</sup> and return cars to your homes the evening of May 12<sup>th</sup>.

## • Friday, May 13th

The other half of Victory Point Drive.

Parking Instructions: Same parking arrangements as noted above. Please position cars by nightfall on Thursday, May 12<sup>th</sup> and return cars to your homes by the evening of May 14<sup>th</sup>.
